

<u>Joseph McCloskey Schmidt Scholarship</u> <u>Applicant Requirements 2026 – 2027 School Year</u>

- Student must be entering the 8th grade at a college preparatory high school for the 2026-2027 school year.
- Student must have a minimum 3.0 overall GPA.
- Student must display acceptable conduct and attendance in school.
- Student must be involved in school clubs, athletics, church, community and/or volunteer activities.
- Student must plan to attend college after high school graduation.
- Students standardized test scores must meet the minimum requirements listed below. Each school takes different tests, submit the scores of the standardized test your school administers.

Minimum Standardized test requirements:

LEAP – Basic or above in all subject areas

High School Placement Test - 50%ile or above

ACT Aspire – 50%ile or above

Documents required for application:

- 1. Complete the Parent/Student Application.
- 2. Submit at least 2 recommendation letters that can be written by teachers, coaches, church, and/or community leaders.
- 3. Submit report cards for the past 3 years.
- 4. Submit standardized test scores for the past 3 years.
- 5. Submit any past evaluations.
- 6. Submit all financial records/documentation listed on page 10.

Applications will not be considered until all documents are received. Applications must be postmarked by April 17, 2026.

 - d. Schedule D Capital Gains and Losses
 - e. Schedule E Corporation or Rental Property Income
 - f. Schedule F Farm Income
- 4. Most recently filed business tax return (if applicable): 1040, 1065, 1120, 1120S
- 5. Documentation for any supplemental income for each parent(s): Social Security, Welfare, Food Stamps, Child Support, 1099-M Forms, Workers Compensation, Unemployment, Veterans Benefits etc.
- 6. Louisiana TANF (Temporary Assistance for Needy Families)
- 7. Any other non-taxable income received.
- 8. Proof of household expenses examples including Rent/Mortgage, Utilities, Car Note, Student Loans, Medical Bill etc...
