- 4. Most recent filed business tax return (if applicable): 1040, 1065, 1120,1120S
- 5. Documentation for any supplemental income for each parent(s): Social Security, Welfare, Food Stamps, Child Support, 1099-M Forms, Workers Compensation, Unemployment, Veterans Benefits etc.
- 6. Louisiana TANF (Temporary Assistance for Needy Families)
- 7. Any other non-taxable income received.
- 8. Proof of household expenses examples including: Rent/Mortgage, Utilities, Car Note, Student Loans, Medical Bill etc...
